ONE CASE FROM 2016 IS ILLUSTRATIVE. WE REPRESENTED A MOTHER WHO HAD ENDURED OVER EIGHT YEARS OF SEVERE DOMESTIC ABUSE. ONE DAY, HER HUSBAND CALLED THE COPS AND REPORTED THAT SHE HAD HIT HIM, WHICH WASN'T TRUE. DESPITE OVERWHELMING EVIDENCE TO THE CONTRARY, THE POLICE ARRESTED HER.
